- 1. I/We shall make the installation at my/our expense and at my/our risk;
- 2. I/We are aware that structural alterations are prohibited;
- 3. I/We shall ensure that this installation conforms with all governmental regulations and requirements and all the provisions of the Condominium Corporation's Bylaws and Policies and any other conditions set out herein:
- 4. I/We shall complete the installation as it is described above and on the attached sketch and in any other information included or added hereto, including all conditions and stipulation set out by the Board;
- 5. I/We shall pay on demand any additional insurance costs that are charged to the Condominium Corporation by reason of the installation and any other costs incurred by the Condominium Corporation as a consequence of this undertaking;
- 6. I/We shall save the Condominium Corporation harmless from any claim, damage or expense that may in any way occur by reason of the installation or by reason of the Condominium Corporation incurring costs of maintenance or the removal of the installation and restoration of the property as may be required by the Board and that I/We fail to perform as requested;



- 7. I/We agree that the Condominium Corporation shall not be responsible for any maintenance or maintenance costs for the installation, and that these responsibilities and costs shall be borne entirely by me/us. I/We further agree to maintain the installation or to modify the installation to any standard that the Board may establish from time to time;
- 8. I/We agree that the Board may deliver any notice signifying its pleasure by delivery of a written notice to the property and I/We agree to comply with the Board's requirements within seven days of delivery of this notice, after which date the Board may act at my/our expense without further notice to me/us;
- 9. I/We agree that this undertaking is an indemnity that is both real and personal and as such is binding on me/us, on my/our estate and on any subsequent owner of the property. To that end, the Condominium Corporation may cause a caveat to be registered against the title to the property;
- 10. I/We agree that the installation must be completed within ninety days of the Approval Date.
